We are attending all ODE online meetings with updates to Ready Schools, Safe Learners with guidance for reopening. Our staff is dedicated to placing our families at the center of our planning for 2020-21 school year. Our parent’s preference is in-person learning and our population size would allow us to offer on-campus instruction 5-days a week for all students while still maintaining small cohort sizes and limiting interaction between rooms. *We are also a licensed Emergency Child Care facility and will continue to offer emergency child care until we are able to fully return to school.

Agia Sophia Academy will implement our Comprehensive Distance Learning Plan in order to comply with the State of Oregon's decree that school will only be in person once certain metrics are met in each county. Washington County currently has not met those metrics. Our CDL is slated to being September 2nd but we may push that start date to September 9th in order to be prepared.

Our school is very small (around 30 registered students for Fall 2020-2021). Our school owns 18 student laptops that can be checked out for distance learning by our families as needed. We are an already established community. We will begin each day with virtual morning prayers as a whole school. Students will divide into their classrooms to meet with their main teacher via zoom. Classwork will be assigned via google classroom or through online programs such as Dimensions math, Duolingo (for foreign language practice), RAZ kids for Daily 5 reading to self and listen to reading. Each teacher, after lessons, will remain online for office hours and to offer extra help to students who need it. Our specialty classes of music, PE, and Art will be offered online.

We do have a large number of ELL students so we will be offering cohort time on campus for students that need that extra help.

As soon as our county meets the metrics for reopening schools, we will move to a hybrid model where parents will decide if they want to send their children to the school or continue with digital learning. Our class sizes are currently 10 students per room (with one teacher) which makes following a cohort system very easy to implement. We had already finished our operational blueprint when the announcement had been made regarding moving schools to a comprehensive distance learning model. We will continue to monitor guidance from ODE, OHA, and ELD (as we have an emergency child care facility on campus).

We plan to remove extra furniture into unused rooms to make additional space, as well as removing fabric-covered furniture for safety/cleaning. Most specialty teachers will teach in the student classroom instead of their own rooms and will use masks or face shields.
